
Thank you for meeting with a representative of Opportunities New Brunswick to present your company's profile and discuss the issue of paid plasma collection in Canada.

I wish to confirm that the Government of New Brunswick does not have any legislative measures or regulations in place that would prohibit private paid plasma collection within the province. I also wish to confirm that the Government has not introduced, nor does it plan to introduce any new legislative or regulatory measures that would prohibit, or act as a barrier to this type of operation.

As you are already aware, there are some existing licensing requirements for those facilities that collect human blood and blood products. However, these requirements are not likely to present a barrier to operations for a plasma collection clinic.

Again, thank you for meeting with us. I wish your team the best as you develop a plasma processing business in Canada.
